



Terms and conditions of the competition "Art Lives Here - by Leonardo Hotels", for an artistic residency in Warsaw in 2024

Article 1.

1. The organiser of the Competition "**Art Lives Here - by Leonardo Hotels**", (hereinafter referred to as the "Competition") is Leonardo Hotels Warsaw Sp. z o. o., registered under NIP: 5223080300, with its registered office at Grzybowska 45, 00-844 Warsaw (hereinafter referred to as the "Organiser").
2. The competition is in no way sponsored, endorsed or run by or associated with Facebook, Pinterest, or Instagram. Facebook, Pinterest or Instagram are in no way responsible for any activities related to the organisation of the competition on the website.
3. The Organiser declares that the Competition is not a game of chance or a betting game within the meaning of the Act of 19 November 2009 on gambling games (consolidated text: Journal of Laws of 2023, item 227).
4. The Competition Organiser reserves the right to amend these Rules at any stage of the Competition. Any matters not covered by these Rules shall be decided by the Organiser.

Article 2.

The aim of the Competition is to support artists through:

- a. Organisation of an artistic residency in hotels belonging to the Leonardo Hotels chain in Warsaw, for the Winners of the Contest (hereinafter: "Winners of the Contest"), i.e., in NYX Hotel Warsaw, at 71 Chmielna Street and in Leonardo Royal Hotel Warsaw, at 45 Grzybowska Street;
- b. To create a space and support the preparation of residency works in line with the theme "**Artist inspired by the urban landscape**";
- c. Public presentation of the works prepared during the residency by the Winners of the Competition.

Article 3.

1. The competition is aimed at photographers.
2. Participants in the Competition may be any adult person with artistic achievements who has read these Rules and accepts all their provisions.
3. Employees and representatives of the Organiser or other entities directly involved in the preparation and conduct of the Competition are not permitted to participate in the Competition.
4. The competition is aimed at artists residing in Poland, neighbouring countries, the Baltic States and Scandinavia (Central European and Scandinavian countries).
5. Participants entering the competition must speak English at B2 level.
6. Participation in the competition is free of charge and voluntary.

Article 4.

1. Applications for the Competition shall be made between 06.05. and 02.06.2024.



2. Entries to the Competition shall be made by e-mail to: artliveshere@leonardo-hotels.com.
3. Entries to the Competition should include:
 - a. Application form, in which the following in particular must be provided: name, electronic mail address (e-mail), contact telephone number,
 - b. Declaration that you have read the personal data information clause (RODO),
 - c. A statement that none of the submitted entries are currently taking part in any other competition,
 - d. Declaration of consent to the processing of personal data for the purposes of the Competition,
 - e. Statement of consent to use of image,
 - f. A portfolio of the Competition Entrant's selected works, together with a description, which will be submitted to the Competition Jury in order to select the Competition Winners,
 - g. One work saved in JPG format selected for publication by the Organiser on social media to promote the Competition. The photo should be described with the title, date of creation, name of the series.
4. All documents necessary to complete the Entry (listed in paragraph 3 points a - e) should be downloaded by the Competition Participant from the website <https://www.nyx-hotels.com/art-at-nyx>, filled in and signed by hand, then scanned and sent to the address given in paragraph 2.
5. Each work of a Competition Participant included in the Portfolio should be described by stating the title of the work, the title of the series (if any), the year of creation and the identity of the author of the work (e.g. name or pseudonym).
6. The works included in the Competition Participant's Portfolio do not have to relate to the theme of the residency "Artist inspired by the urban landscape".
7. The portfolio submitted in the Application should be a single file in PDF format.
8. By submitting a complete Entry, the Entrant accepts and undertakes to comply with these Rules.
9. The participant entering the competition agrees to the use, recording and reproduction of his/her work referred to in paragraph 3(g) by the Organiser for the purposes of promoting the competition in social media, as well as publication in newspapers, periodicals, occasional magazines, brochures and electronic publications

Article 5.

1. The Competition is open only to works in the form of photographs.
2. The Competition is only open to entries which, as at the date of the Entry, are not taking part in any other competition.
3. The participant declares that the works submitted by him/her are his/her original author's work and fulfil the definition of a work within the meaning of the Act of 4 February 1994 on copyright and related rights (consolidated text: Journal of Laws of 2022, item 2509).
4. Entries for which third parties hold the copyright will not be considered.
5. In the event that the works are not of the Participant's authorship, the Participant will be obliged to return the benefits received and to compensate for the damage.
6. It is unacceptable for the Entrant to submit a competition entry that contains content that is illegal or infringes the rights or personal interests of third parties.



7. The Organiser reserves the right to reject Competition Entries that do not meet the conditions indicated in the Rules.

Article 6.

1. The selection of the Competition Winners and Distinguished Artists will be the responsibility of the Competition Jury appointed by the Organiser.
2. The organiser reserves the right to change the composition of the Jury during the Competition without stating reasons.
3. The Organiser declares that the Jury of the Competition is completely independent in its decision-making regarding the selection of the Winners of the Competition and the Winner of the Competition, as referred to in Article 9(1).
4. The Jury's choice is final and not subject to appeal.

Article 7.

1. The Competition Jury will select three Competition Winners from among the correctly submitted entries no later than 7 days after the closing date for receipt of entries.
2. Winners' profiles will be posted on the Organiser's website and in traditional and social media.
3. Winners of the Competition will be notified of the results by email no later than 30 days before the start of the residency period.

Article 8.

1. The winners of the Competition will be invited to a 17-day residency between 08.07 - 25.07.2024, during which they will be provided with:
 - a. Overnight stay including breakfast at Leonardo Royal Hotel Warsaw, 45 Grzybowska Street, Warsaw.
 - b. Access to an art studio prepared in one of the hotel rooms.
 - c. Afternoon meal in the form of dinner at one of the Organiser's two hotels in Warsaw.
 - d. Reimbursement of travel expenses, based on receipts, VAT invoices or named tickets provided.
2. During the residency, each of the Competition Winners will make a series of works consisting of no less than 5 photographs consistent with the theme of the residency "Artist inspired by the urban landscape".
3. The works included in the series should not exceed 100x70 cm in size.
4. During their residency, the Competition Winners may be asked to give written, audio or video statements - for the purpose of promoting the Competition and the Organiser.

Article 9

1. At the end of the residency, all the works created during the residency, as referred to in Article 8(2), will be assessed by the Jury, which will determine the Winner of the Competition.
2. The winner of the Competition will be announced by the Organiser on 24.07.2024.
3. All the works of the Competition Winners will be presented at a vernissage organised on 24.07.2024.



4. The winners of the Competition agree that the Organiser may use, record and reproduce their works referred to above for the purposes of organising and promoting the vernissage in social media, as well as for publication in newspapers, periodicals, occasional magazines, brochures and electronic publications.
5. The winning series of works will be purchased by the Organiser and placed in the hotel space of Leonardo Hotels Warsaw Sp. z o. o.
6. The winner of the Competition undertakes to enter into an appropriate agreement with the Organiser for the sale of the series of works.
7. The organiser will purchase the work for an amount not exceeding EUR 1,000.
8. As a prize in the Competition, it is understood that the Organiser will cover the cost of a 17-day residency, including meals, and the provision of the necessary materials to complete the work.
9. The average prize equivalent per Competition Winner (who is a participant in the residency) is £15,000.
10. The remaining works will be returned to the Competition Winners to the address indicated in the form included in the Competition Entry at the Organiser's expense within 90 days of the closing date of the vernissage.

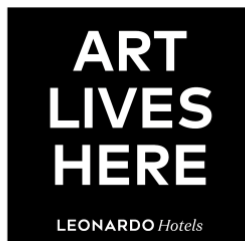

Appendix 1 to the Regulations of the "Art Lives Here - by Leonardo Hotels" Competition

Information clause on personal data (RODO)

1. The administrator of the personal data is Leonardo Hotels Warsaw Sp. z o. o., registered under NIP: 5223080300, with its registered office at Grzybowska 45, 00-844 Warsaw, hereinafter referred to as the "Administrator".
2. The personal data referred to in paragraph 1 shall be understood as the data provided by the Competition Participants in the application form referred to in Article 4(3)(a) of the Rules and Regulations, in particular: first and last name, address of residence, e-mail address, telephone number and titles of works included in the Portfolio attached to the Application referred to in Article 4(3)(f) of the Rules and Regulations.
3. The personal data referred to in paragraph 2 will be processed by the Administrator for the purposes of achieving the objectives of the Competition referred to in Article 2 of the Rules and for the purposes of promoting the Competition and the Organiser, on the basis of Article 6(1)(a) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (Official Journal of the EU L 119 of 4 May 2016; hereinafter referred to as RODO).
4. The Administrator's processing of personal data within the scope of paragraph 2 will only be possible with the consent of the Contest Participants.
5. Personal data, once a contract as defined in Article 6(3) of the Terms and Conditions has been concluded, will be processed by the Administrator under Article 6(1)(b) of the DPA for the purpose of fulfilling the contract.
6. The controller has rights to process personal data in relation to the controller's legitimate interest for the purposes of redress and defence against claims under Article 6(1)(f) of the DPA.
7. The personal data will be processed for the period necessary for the above-mentioned purposes, not longer than the obligations provided for by law or until the expiry of the period of limitation of claims of either party to the contract set out in Article 6(3) of the Regulations.
8. Personal data may only be transferred to a third country, i.e. a country which is not part of the European Economic Area (EEA), if that country ensures an adequate level of security for the protection of personal data and the transfer is permitted by law.
9. Personal data will not be transferred to third parties, including international organisations, unless this is necessary in order to meet the needs set out in paragraph 3 or by law.
10. Recipients of the data may be persons whom the Administrator authorised to process personal data or concluded a contract for the processing of personal data, entities entitled to receive data on the basis of applicable laws, including competent judicial authorities or entities to which the transfer of data is necessary for the proper performance of the contract. Recipients of the data for the purpose of proper performance of the contract may be telecommunication entrepreneurs, banks, postal operators, carriers, companies handling correspondence, accountancy, hosting provider, vehicle manufacturer, companies providing technical services to the controller. For a list of recipients of personal data, please contact the Administrator.
11. Data subjects have the right to request from the Data Controller access to their personal data, rectification, erasure or restriction of processing, or to object to the processing of their personal data, as well as the right to data portability and the right to lodge a complaint with



the supervisory authority, i.e., the President of the Office for Personal Data Protection, in the event that the data subject considers that the regulations have been violated. If the data is processed on the basis of the consent given, it is possible to withdraw it at any time. However, this does not affect the correctness of the data processing until the consent is withdrawn.

12. Contact regarding personal data with the Administrator is made by e-mail to: artatnyx@leonardo-hotels.com.
13. The provision of personal data is voluntary, although required to participate in the Competition and enter into the Contract. Submitting a request for deletion or restriction of processing may result in removal from the Competition or termination of the contract if it is not possible to fulfil the obligations under the Contract without such data.
14. On the basis of the personal data provided to the persons referred to in paragraph 2, the Administrator declares that it will not make automated decisions, including decisions resulting from profiling within the meaning of the RODO.
